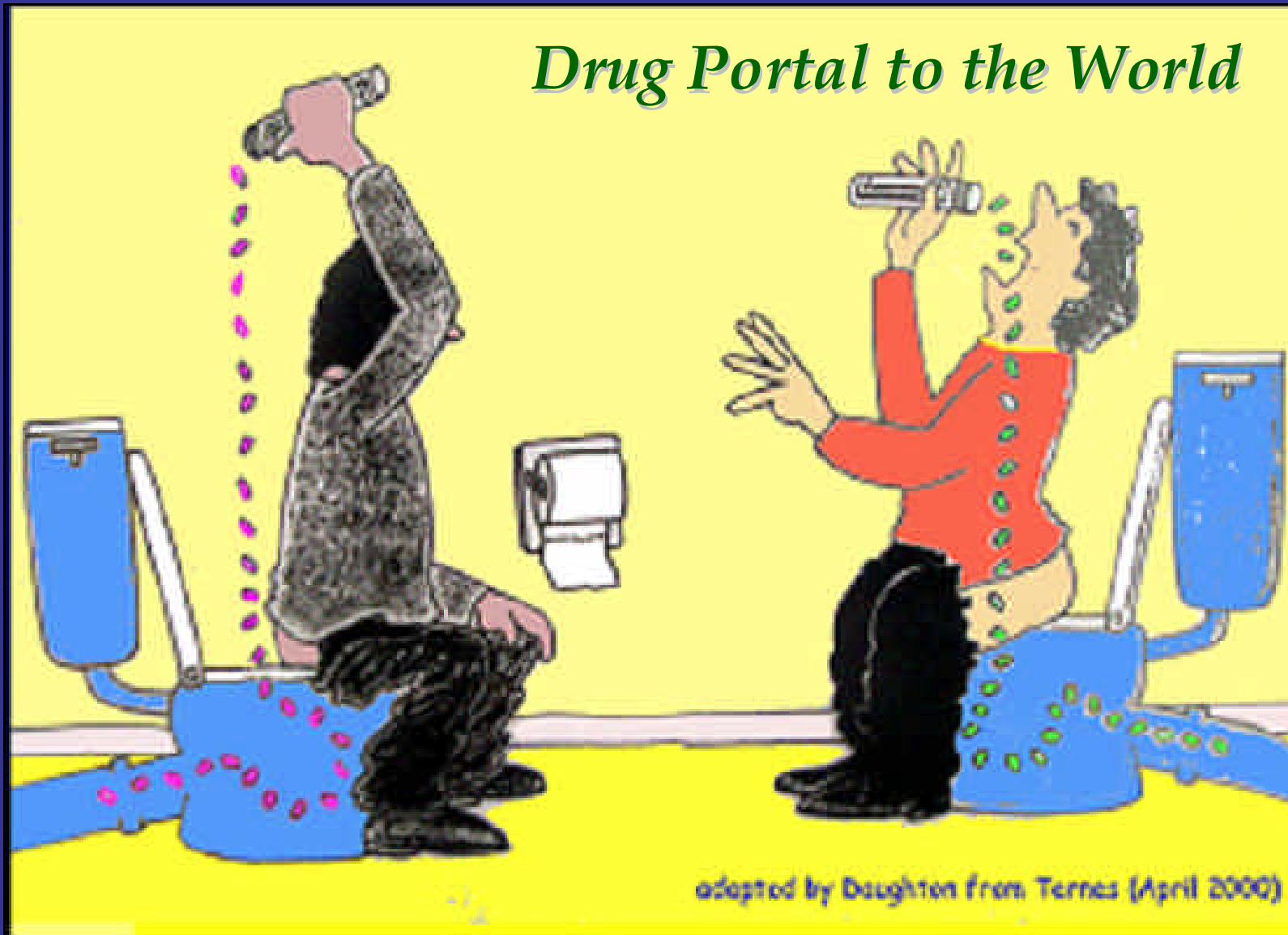
What are Endocrine Disruptors?

- hormones regulate mood, growth & development, tissue function, metabolism
- Major endocrine glands are pineal, pituitary, thyroid, thymus, adrenal, pancreas, ovary and testis – over 60 hormone chemicals
- EDs act like hormones but disrupt the function of true hormones.

Where are all the pharmaceuticals coming from?

- Manufacturing
- Hospitals and other medical facilities
 - Hospice, long term care, clinics, vets
- Human use
 - Excretion and flushing
- Agriculture
- No one know how much is being contributed by various sources

Drug Portal to the World

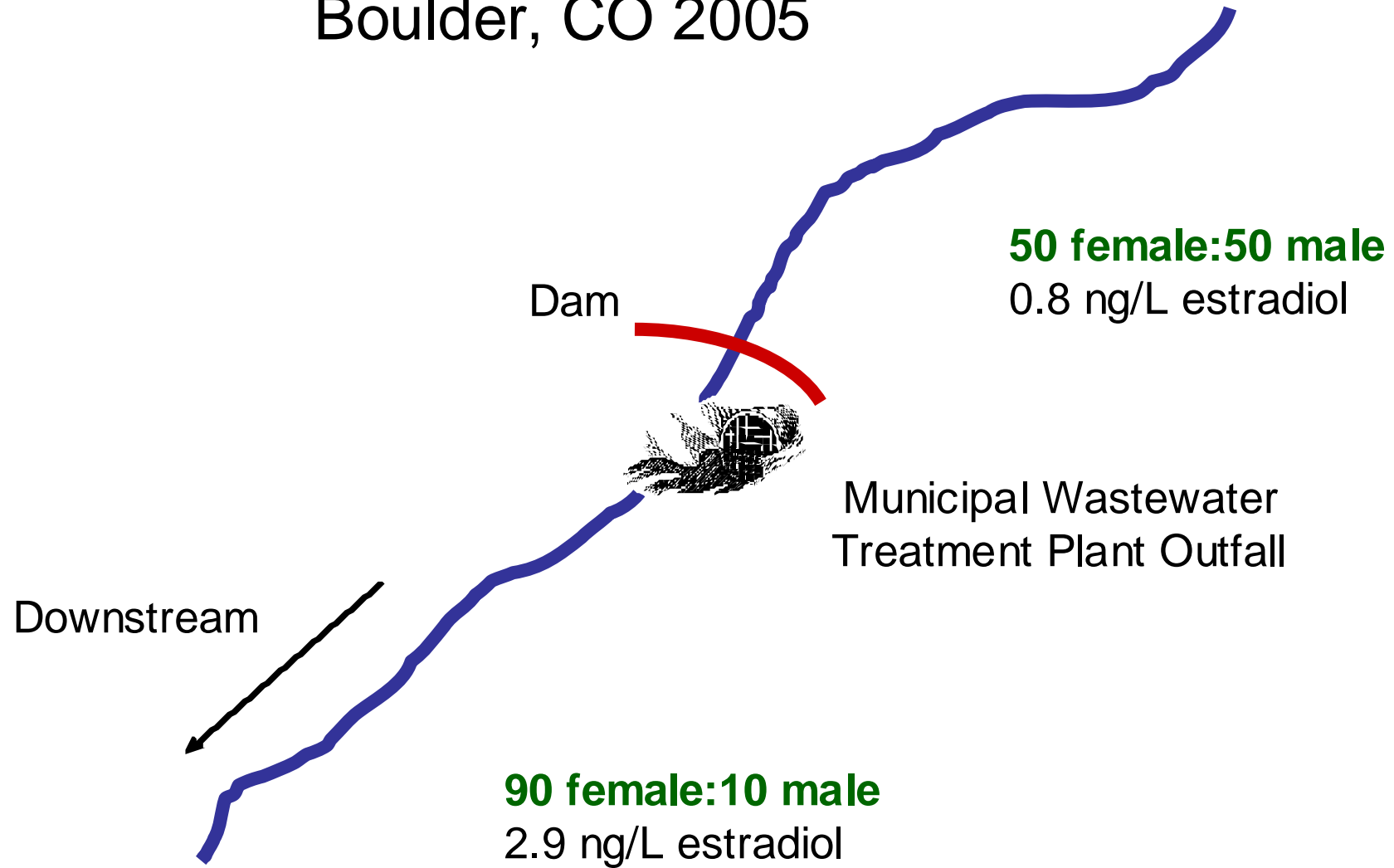




Who is watching this issue?

- EPA - water issue, not hazardous waste
- DEA – drug diversion & controlled substances (drugs with potential for abuse)
- Big Pharma – drug manufacturers
- Media – not always well reported
- Consumers
 - Don't want to feel helpless!
 - Their perceptions drive programs

Chemical Cocktails

- Standard lab analysis and field study examine one chemical at a time
- Multiple chemicals are typical in the environment
- Effects of these “cocktails” are just starting to be studied



Is It “Hazardous”?

- Only about 5% of drugs are regulated under existing RCRA regulations from the '70s.
- The remaining 95%? How do we measure health effects from both traditional toxicity measures and newer criteria, such as antibiotic resistance, endocrine disruption, and developmental disruption due to prenatal or early postnatal exposure?

Does it cause cancer?

- Often used to gauge health effects
- Endocrine disruption, antibiotic resistance, and developmental disruption due to prenatal or early postnatal exposure are also important criteria.

“Pharming”

- For kids between 12-17, abuse of prescription pain killers now ranks second—only behind marijuana—as the Nation’s most prevalent illegal drug problem
- Viewed as “safer” than illegal drug use
- Prescription drug death rate was 3 times the rate of deaths caused by all illicit drugs combined – Florida, 2007

Precautionary Principle

- “When an activity raises threats of harm to human health or the environment, precautionary measures should be taken even if some cause and effect relationships are not fully established scientifically.”

Sound Science

- “We can’t manage what we can’t measure.”
- With new analytical methods, we can find things at vanishingly low quantities – and for \$\$\$\$
- We need to combine research with action.

How to Dispose of Unwanted Medications

Expired or unwanted prescription and over-the-counter medications from households are typically disposed of by flushing them down the toilet or a drain. Although this method of disposal prevents immediate accidental ingestion, it can cause contamination in our aquatic environment because wastewater treatment systems are not designed to remove many of these medications.

Seven Steps to Safety

Please use these practical guidelines when disposing of prescription and over-the-counter medicines:

For Pills and Liquid:

1. Keep the medicines in the original container. This will help identify the contents if they are accidentally ingested.
2. Mark out your name and prescription number for safety.
3. For pills: add some water or soda to start dissolving them. For liquids: add something inedible like kitty litter, dirt or cayenne pepper.
4. Close the lid and secure it with duct or packing tape.
5. Put the bottle(s) inside an opaque (non see-through) container like a coffee can or plastic laundry bottle.
6. Tape that container closed.
7. Hide the container in the trash. Do not put in the recycle bin.



• DO NOT give drugs to anyone else

• DO NOT flush drugs down the toilet

• DO NOT put drugs in the trash without disguising them – human or animal scavengers may find them and misuse them.

Federal Guidelines

- Office of National Drug Control Policy
- How they differ from ours
 - Remove from original container vs. leave in container & mark out your ID
 - Flush if they are labeled as such
 - with a list of drugs to be flushed
 - We feel this just confuses people and could lead to more flushing

Florida Collection Events

- Ongoing collection at some Household Hazardous Waste programs in Florida are NOT our recommendation
 - Unfair cost for counties to assume
 - Liability of having drugs on site
- Operation Medicine Cabinet
 - Collier County – by Substance Abuse Coalition of Collier County
 - Homeowner collections at parks and community centers
 - Continuing collections at HHW
- Other scattered events and interest

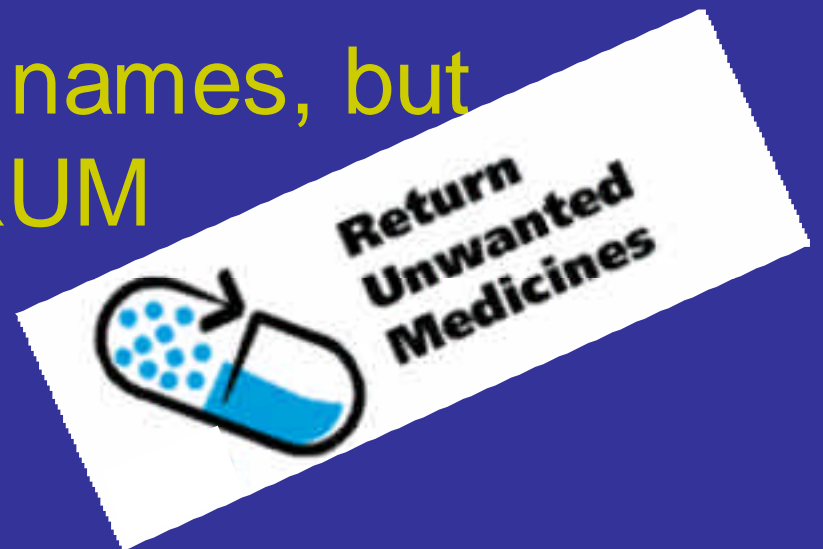
Existing Programs: Pharms (Pharmaceuticals from Households: A Return Mechanism)

Existing Programs

- RUM – Australia's Return Unwanted Medicine program allows returns to pharmacies – paid for by drug mfrs & government.
- Canada – no snappy names, but programs similar to RUM in several provinces

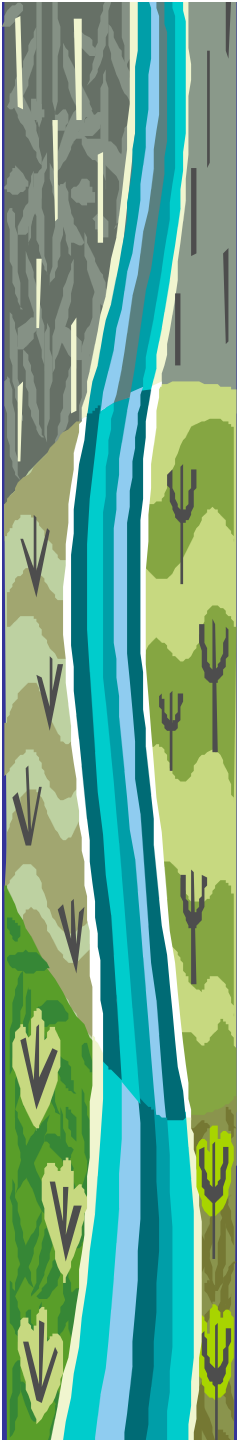


Where We're Going



Solutions

- Upstream [pollution prevention]
 - Less doctor prescription
 - Less patient use
 - Better patient compliance (fewer unused)
 - More efficient drug delivery (less excretion)
- Downstream [waste/wastewater management]
 - Recycling, unused medicine exchange
 - Wastewater Treatment (improved removal)
 - Legislation?
 - “Extended Producer Responsibility”; “Product Stewardship”



Legislation

- Florida – 2009, 2 proposed bills died in committee. Nothing proposed for 2010.
- Maine – approved mail back program
- Minnesota, Oregon, Washington all have proposed bills.
- If bills only provide take-back events – not a sustainable solution
- Federal – amend Controlled Substances Act

When Smoke Ran Like Water by Devra Davis

- “All this sexual confusion in wildlife probably is not good for us either. How can we be sure ...what it may mean? . . . We are surely different from deer and whales and polar bears, but we may not be different enough.”

What can YOU do?

- Use less Rx medication
 - Ask your doc for non-medical treatments
 - Only fill Rx if you really need it
 - Use diet, exercise, and avoid chemical exposures to improve your health
- Safeguard medicine in your home
- Safely dispose of medicine you do not need – do not flush!
